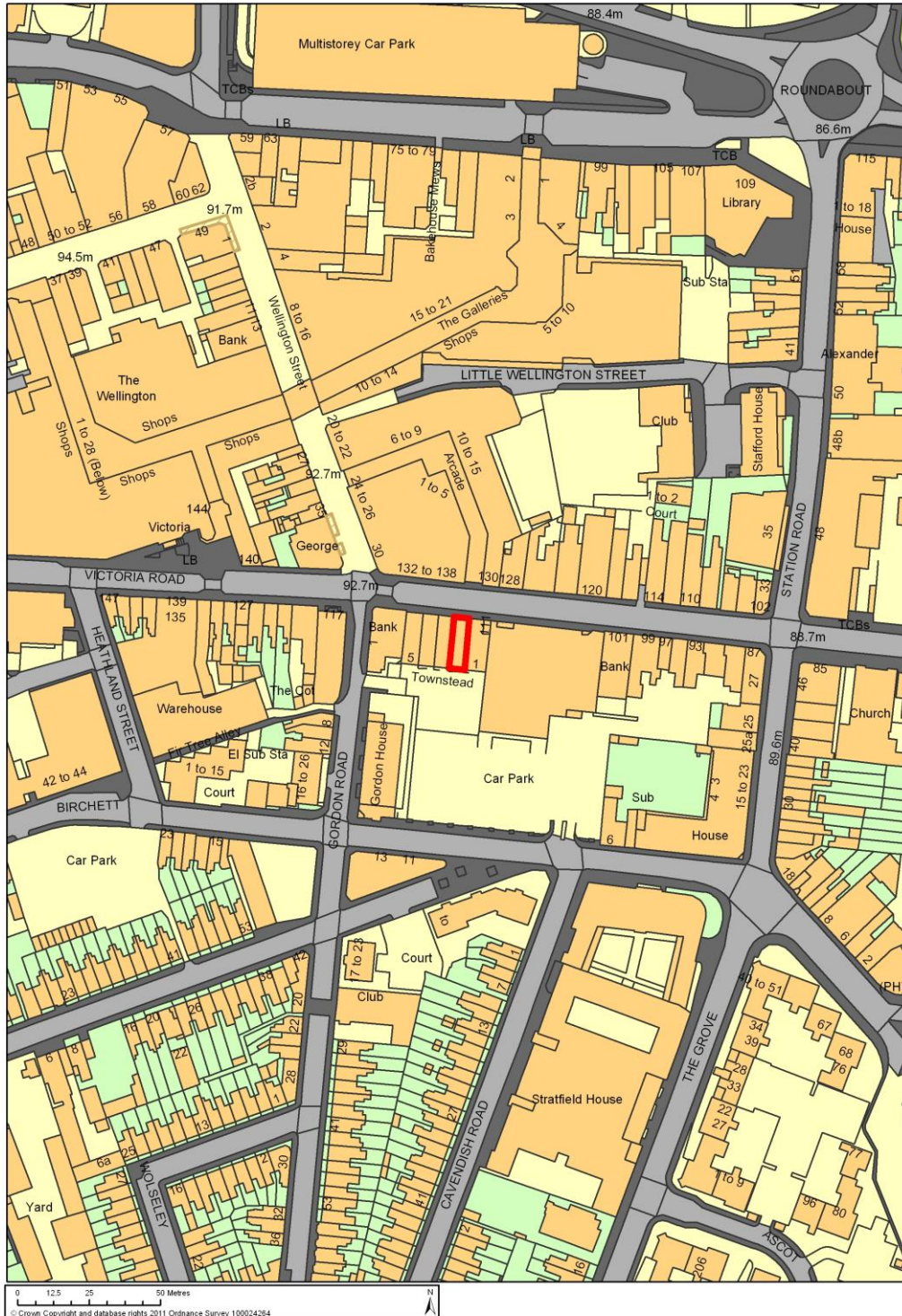
- (1)
  - (i) A zero tolerance approach shall be taken towards the presence and use of illegal drugs on the premises. This policy shall be actively enforced at all times.
  - (ii) Management and staff shall immediately inform the police of any activity where the presence or use of illegal drugs on or in the vicinity of the premises is suspected or observed.
- (2) No refreshments shall be served in glass containers.
- (3) Except for access and egress, all external doors and windows must be closed and kept closed any times licensable activities take place.
- (4) The licence holder shall request patrons and staff to respect the needs of local residents and to leave the premises and area quietly.
- (5) No music shall be played in the premises at any time when licensable activities are permitted.
- (6)
  - (i) Delivery drivers operating from or on behalf of the premises shall not leave their vehicle engines running / idling at any time when not in motion and/or when parked in the vicinity of the premises.
  - (ii) Delivery drivers operating from or on behalf of the premises shall be provided with suitable and sufficient instruction regarding the manner by which they should park, enter and/or alight their vehicles so as to ensure the prevention of public nuisance.
- (7) Any individual(s) / customer(s) that persistently cause noise and/or disruption at, or in the vicinity of the premises shall be refused service and/or entry to the premises.
- (8) All equipment (inclusive of the air extraction equipment) used within the premises shall be suitably sound insulated and operated in accordance with its manufacturer's instructions (inclusive of the frequency by which the equipment is subject to maintenance inspection).
