

**THE RUSHMOOR BOROUGH COUNCIL
(OFF STREET PARKING PLACES) (CONSOLIDATION) ORDER 2014**

Rushmoor Borough Council (“the Council”) in exercise of its powers under Sections 32 – 35C and 44 of the Road Traffic Regulation Act 1984 (“ the 1984 Act”) and Part IV of Schedule 9 to the 1984 Act and Part VI of the Traffic Management Act 2004, and all other enabling powers, with the consent of Hampshire County Council (“the County Council”) under section 39 (3) of the 1984 Act, propose to make the following Order, the effect of which is as follows:-

To revoke the Order described in Schedule 1 below and consolidate the provisions of that Order into the new Order referred to above, together with amendments as follows:-

- (i) Removal of free parking for vehicles with a zero rated tax disc, due to the removal of tax discs by the Department for Transport;
- (ii) All Vehicles must display a valid Ticket;
- (iii) Any Disabled Persons Badge holder will receive an extended duration of stay of double the purchased tariff when a valid ticket is displayed in conjunction with a valid Disabled Persons Badge.
The extended duration will only be valid beyond the published duration of a valid purchased ticket.
- (iv) Adding one Parking Place to the Order, as advertised and as appended as Schedule 2 below.

A copy of the draft Order, the statement of reasons for making the Order and drawing showing the area affected, may be examined at the Council Offices, Farnborough during normal office hours.

If you wish to object to the proposed Order, you should send the grounds for your objection, in writing, to the undersigned by **6th October 2014**.
