

## **Resident survey results**

The last Rushmoor Borough Council residents' survey was carried out in 2024, the full results are available on our <u>website</u>. The survey was an online survey and 1,686 surveys were returned, in total 101 residents in St John's ward completed the survey. Although not all wards had a representative number of responses the results can give an indication to what respondents in a ward think.

Respondents from St John's ward have a slightly higher satisfaction with Rushmoor as a place to live than respondents from Farnborough, and all respondents to the survey.

Respondents from St John's ward feel less that they belong to their local area than those from Farnborough, and less than all those who responded to the survey.


### Ward population and makeup 2021




• **Age:** There is not much difference between the age profile of St John's residents and the age profile of Rushmoor as whole.




• **Ethnicity:** St John's ward has a higher percentage of White residents, than Rushmoor as a whole, and fewer Asian residents.




• **Religion:** There is a slightly higher percentage of residents with no religion, when compared to Rushmoor as a whole.






• **Health:** A slightly higher percentage of St John's residents reported very good health, when compared to Rushmoor as a whole.



**Economic activity/inactivity:** St John's ward has a slightly higher percentage of residents in full time employment, when compared to Rushmoor as a whole.



Qualifications: A slightly higher percentage of St John's residents have level 1, 2 and 3 as their highest qualification and a lower percentage have no qualifications, when compared to Rushmoor as a whole





## **Deprivation breakdown**

The Government's Index of Multiple Deprivation (IMD) 2019 provides a relative deprivation score for each small area in England, it covers a range of economic, social and housing issues. The overall score is calculated using data from seven domains. Most of indicator data has come from 2015 and 2016 and some of the data is from the 2011 Census. The Indices of Deprivation cover geographical areas that are called Lower-layer Super Output Area level (LSOA), of which there are 32,844 in the country. There are a total of 58 LSOAs in Rushmoor.

Unfortunately, LSOAs and the council's wards do not exactly line up. In St John's ward there are all or part of four LSOAs. The following map shows the number of the LSOAs in St John's ward and the approximate percentage of the LSOA in the ward. Each LSOA is ranked in order against all other LSOA in the country, where 1 is the most deprived and 32,844 is the least deprived.
