#### **REVIEW OF LICENSING FEES**

#### **SUMMARY AND RECOMMENDATIONS:**

This report outlines background and current fees for the various licensing regimes that have discretionary fees and proposes a new fee scale for each regime.

Recommendations to the Executive Head of Operations, on consultation with the portfolio holder:

- commence consultation on the proposed new fees for street trading in accordance with the legislation. If no significant representations are received, to agree that the proposed fees shall take effect from 1<sup>st</sup> June 2025;
- require a further report on taxi licensing fees to be provided following a decision regarding taxi vehicle plates, current fees to remain in place pending review;
- agree a minor amendment to the mobile homes fit and proper person fees policy as per paragraph 3.9, to enable appropriate cost recovery in this area:
- to agree that Primate Licensing Fees take immediate effect; and
- to agree that all other proposed fees and charges contained within this report take effect from 1<sup>st</sup> May 2025

#### 1. INTRODUCTION

1.1. The purpose of this report is to seek the approval for the amendment of the current licensing fees from 1<sup>st</sup> May 2025.

#### 2. BACKGROUND

- 2.1. The Council is facing significant financial pressures in the upcoming financial year due to the impact of inflation on costs and uncertainty around interest rates and the wider UK economy.
- 2.2. In common with many other local authorities, the Council is also forecasting a funding gap over the Medium-Term Financial Strategy (MTFS) period. A Savings and Transformation Programme is already in place with the Council

- working on a number of cost reduction and income generation workstreams to mitigate the financial sustainability risk outlined in the MTFS.
- 2.3. In light of the financial pressures and the funding gap over the medium-term, services are expected to regularly review their services to ensure costs are minimised and income from fees and charges take into account issues of cost recovery. This report sets out the position on licensing fees and should be seen in the wider context of strong budgetary control and robust financial management as a proportionate and balanced response.
- 2.4. For licensing regimes, the application fee is payable at the time an application is made to cover the cost of processing the application, the enforcement fee is payable only when a licence or permit is granted, and is to cover the ongoing costs of administering the licence.

## 3. DETAILS OF THE PROPOSALS

## **Animal Licensing**

- 3.1. Under the Animal Welfare Act 2018, local authorities may only charge on a cost recovery basis and there is guidance in respect of how fees should be calculated.
- 3.2. Fees were last reviewed in 2022, since this time we have invested in training members of the licensing team and have now handed in notice to our contractor, so that we can carry out animal licensing inspections in house. As such, the recommendation is that a number of the fees reduce when the application and enforcement fees are combined, as this is more cost effective.
- 3.3. With the move to in-house licensing, it is possible to simplify the fee structure, which has also been done as part of this review.
- 3.4. In addition, there is a new licensing regime for the keeping of primates, which we are required to implement from April 2025, as such the proposal includes fees for this.

# Mobile Homes Fit & Proper Person Registration

- 3.7. Under the Mobile Homes (Requirement for Manager of Site to be Fit and Proper Person) (England) Regulations 2020, local authorities may only charge on a cost recovery basis and there is guidance in respect of how fees should be calculated.
- 3.8. In accordance with the legislation, Rushmoor Borough Council have a Fit and Proper Person Fees Policy and the fees are required to be set in accordance with this. This policy and the current fee were set based on best estimates for the work involved when the regime was implemented. We have now been able to calculate based on the actual time taken to administer the regime.
- 3.9. Notably, the current policy does not include any element for covering the cost of policy, fee setting and review of these and procedures. In light of this, and the need to ensure appropriate cost recovery, it is recommended that the portfolio holder for neighbourhood services, agrees that these should be added at paragraph 3.0 of the policy so that they can be taken into consideration.
- 3.10. The current application fee is £339, with an annual fee of £37 per specific condition added to the registration in addition to the standard conditions.
- 3.11. Assuming the change of policy recommended at 3.9 above, the proposed fee is £560.33 for a new application, £515.33 for a renewal application, and £50 per year for each additional non-standard condition.

# **Pavement Licensing**

- 3.12. Since the pavement licensing fees were last reviewed, temporary legislation has been made permanent, and the previous tables and chairs permitting regime has been repealed.
- 3.13. The Business and Planning Act 2020 (as revised) states that fees should be based on cost recovery and specifies a maximum total fee of £500 for a new licence, and £350 for a renewal.
- 3.14. Currently the fee is set at £100 for both new and renewal applications, as this was the previous maximum fee in the temporary legislation.
- 3.15. The proposed fees are £383.09 for a new application, with a £59.85 enforcement fee payable on grant (in accordance with paragraph 2.4), and £313.26 application fee on renewal.

## Sex Establishment Licensing

- 3.16. The Local Government (Miscellaneous Provisions) Act 1982 states that licensing authorities can charge a reasonable fee for applications for sex establishments, which should be based on cost recovery in accordance with relevant requirements. The fees were last reviewed in 2014. Currently we have no licensed sex establishments in Rushmoor.
- 3.17. Currently the fee is set at £1115 for both new and transfer applications, with renewal set as £270. There is no current fee set for variation of a licence.
- 3.18. The proposed fees are £2052.95 for a new or transfer application, £692.15 for renewal and £231.47 for a variation. As we currently have no licensed sex establishments, there is no proposed enforcement fees.

#### **Scrap Metal Licensing**

- 3.19. Under the Scrap Metal Dealers Act 2013, local authorities may only charge on a cost recovery basis, and there is guidance in respect of how fees should be calculated. Fees were last reviewed in 2022. At that time no fee for variation was set, however there is a mechanism for this in the legislation, and therefore a fee for this is proposed.
- 3.20. The proposed fees are as follows:

- 3.22. Under the Local Government (Miscellaneous Provisions) Act 1982, local authorities may charge what is reasonable for the grant of a street trading consent. Fees were last reviewed in 2022.
- 3.23. The proposed fees are as follows:

3.25. Before varying changes to the fees, the legislation requires local authorities to give notice to current licence holders and publish a notice in a local newspaper advertising the proposed changes and giving a reasonable period for representations. It is proposed that we allow a period of 28 days for representations, and if there are no significant representations received

within this period, that the proposed fees are implemented with effect from 1<sup>st</sup> June 2025.

### Taxi Licensing

- 3.26. Under the Local Government (Miscellaneous Provisions) Act 1976, local authorities may only charge on a cost recovery basis for certain elements of taxi licensing, and there is guidance in respect of how fees should be calculated. Fees were last reviewed in 2010.
- 3.27. Given the length of time since the last review some of the proposed fees on a cost recovery basis are likely to be a significant rise, however we are currently exploring alternative options for taxi vehicle plates, which would be more environmentally friendly, and potentially reduce costs, which would go some way towards counteracting this.
- 3.28. As such, the recommendation is that the review of taxi vehicle plate options is completed prior to fees being amended, in order to ensure that any savings can be implemented at the same time, to have a lesser impact on licence holders.

# Benchmarking

3.29. The fees and charges for Rushmoor's immediate neighbouring authorities for those regimes where amended fees are proposed are given at **appendix A.** 

#### **Alternative Options**

3.30. No change. Fees would remain unchanged and we would not recover the costs we are able to, and would be open to challenge on the basis that costs are not based on cost recovery.

#### 4. IMPLICATIONS

#### Risks

4.1. There are no risks associated with this report.

## **Legal Implications**

4.2. The Council is obliged to work within the relevant regulations to avoid any income over and above a cost recovery basis. There are no other legal implications for this report.

#### **Financial and Resource Implications**

4.3. If fees are not increased, cost recovery is not achieved and there will be a budgetary shortfall in some areas, and additional income in others. It has taken a significant amount of time to review the fees and charges that have not been updated for some time, and amending the fees so that they are correct will mean that an annual review will be less resource intensive going forward.

# **Equalities Impact Implications**

4.4. There are no equalities implications arising from this report, the fees and charges apply to all applicants and licence holders regardless of any protected characteristics and are based on the cost recovery of providing the service.

# **Community Safety Implications**

4.5. There are no community safety implications arising from this report.

#### 5. CONCLUSIONS

- 5.1. Licensing fees and charges have been reviewed taking account of the costs of providing each service, and the costs that can be lawfully recovered on the relevant legislation.
- 5.2. The Executive Head of Operations, in consultation with the Portfolio Holder for Neighbourhood Services is recommended to:
  - commence consultation on the proposed new fees for street trading in accordance with the legislation. If no significant representations are received, to agree that the proposed fees shall take effect from 1<sup>st</sup> June 2025;
  - require a further report on taxi licensing fees to be provided following a decision regarding taxi vehicle plates, current fees to remain in place pending review;
  - agree a minor amendment to the mobile homes fit and proper person fees policy as per paragraph 3.9, to enable appropriate cost recovery in this area;
  - to agree that Primate Licensing Fees take immediate effect; and
  - to agree that all other proposed fees and charges take effect from 1<sup>st</sup> May 2025
