# Rushmoor Local Plan Policies Map

Schedule of Factual Changes

July 2023

This document should be read alongside the <u>Rushmoor Local Plan Policies Map</u> (February 2019). It provides a schedule of factual changes that have occurred to European, national and local designations that are referenced in the <u>Rushmoor Local Plan</u>.

There are a number of designations shown on the Local Plan Policies Map that are not determined through the Local Plan (in accordance with the Planning and Compulsory Purchase Act 2004). These designations can change after the Plan has been adopted, and the purpose of this Schedule is to record these changes. For example, the policies maps should record the boundaries of any new or amended conservation areas.

The designations that can change and which are detailed on the Rushmoor Local Plan Policies Map include:

- Conservation Areas (Planning (Listed Buildings and Conservation Areas) Act 1990)
- Scheduled Monuments (Historic Buildings and Ancient Monuments Act 1953)
- Nationally Listed and Locally Listed Buildings
- Special Protection Areas (SPAs)
- Sites of Special Scientific Interest (SSSIs)
- Sites of Importance for Nature Conservation (SINCs)
- Local Nature Reserves
- Flood Zones

These factual changes do not impact the approach of the Local Plan and the policies contained within. They seek principally to acknowledge changes to some designations that have been reflected within the Plan.

The table below identifies each change and includes:

- The policy map affected, and the change made
- The justification that outlines the reason for the amendment.


