

HACKNEY CARRIAGE AND/OR PRIVATE HIRE VEHICLE DRIVERS LICENCE APPLICATION

PRIVACY & DATA PROTECTION NOTICE

We may use any information you provide to us, some of which may be sensitive, to process and determine any application you make for the grant or renewal of a private hire and/or hackney carriage driver's licence for the purpose of securing compliance with and enforcement of relevant UK and international laws.

As one of the Council's public tasks, undertaken in the public interest, it is necessary to use your personal information in this way to provide our services, carry out our functions and responsibilities in accordance with these laws and the Council's licensing policies and to keep our records up to date.

We may share the information you provide to us with other parts of the Council in order to carry out the Council's statutory functions. We may also share this information with outside bodies for the purposes of law enforcement or the sharing is in the public interest.

In particular, we may share information with those within the Council who can help to determine or advise upon applications and authorisations of this kind. This may include, but is not limited to, the Council's licensing officers, senior management, the Members and officers of the Council's Licensing, Audit & General Purposes Committee (or Sub-Committee), and the Council's medical and legal advisers. We may also share your information with the Council's Benefits, Housing, Legal and Democratic Services and Investigations teams. If you ask a Councillor for help we may share your information with them to assist them and you.

We may also, where required to or, permitted by law to do so, pass information about you to third parties. This may include, but is not limited to, other local authorities, government departments, the National Fraud Initiative, the DVLA, HMRC, the UK Border Agency and the police carrying out their tasks in the public interest. Your information may also be shared with the National Register of Taxi Licence Refusals and Revocations (NR3) hosted by the National Anti-Fraud Network which allows licensing authorities to share information about individuals who have had their hackney carriage or private hire driver's licence suspended, refused or revoked or any application for one refused.

Where appropriate some of the information you provide may be made public as part of any public consultation and/or hearing requirements to determine your application or to ensure compliance with any licence issued and related licensing laws. Some of your information may be included in a public register containing details of the applications we receive and any authorisations we grant or refuse.
