Voting by proxy

Proxy voting means that if you aren't able to cast your vote in person, you can have someone you trust cast your vote for you.

If you are not able to attend the polling station in person for reasons relating to your occupation, service or employment, and you only become aware of this **after 5pm**, **on the sixth working day before the poll**, you can apply to vote by emergency proxy (someone else voting on your behalf). You can apply up until **5pm on the day of the poll**.

This form should not be used if you have been detained in a hospital under Section 145 of the Mental Health Act 1983 in England and Wales or Section 329 of the Mental Health (Care and Treatment) (Scotland) Act 2003 in Scotland.

Both you and your proxy must be registered and eligible to vote.

A person can only be a proxy for close relatives and up to two other people at an election or referendum.

Close relatives are the spouse, civil partner, parent, grandparent, brother, sister, child or grandchild of the applicant.

How do I apply to vote by proxy?

- You must ask someone who is willing and capable to be your proxy and vote on your behalf.
- Unless you are registered to vote as a service voter or anonymous elector, you must get an appropriate person to sign your application. See notes below for information on who can support your application.
- Make sure all sections of the form are complete and supply your date of birth and signature. You need to give your date of birth and signature on this application form. This information is needed to prevent fraud. If you are unable to sign this form, please contact your elections team at your council.
- I Return by hand to Elections Office, Rushmoor Borough Council, Council Offices, Farnborough, Road, Farnborough, Hants. GU14 7J or a scanned image. clear photo of the completed form can be emailed to <u>elections@rushmoor.gov.uk</u>.

This form must arrive before 5pm on the day of the poll. Please do not hand it in at the polling station.

If you are not already registered to vote, you must register before applying for a proxy vote. The deadline to register to vote is **midnight**, **12 working days before the poll**. Register to vote online at **gov.uk/register-to-vote**

Who can support my application?

Your application can be supported by:

- an employer or another authorised person at the place of work (if employed)
- a person who knows you and is not related to you (if self-employed).

In England, your supporter must be aged 18 or over.

In Scotland, if you are self-employed your supporter must be 16 or over to support your application for local elections and elections to the Scottish Parliament. They must be 18 or over to support all other applications.

In Wales, if you are self-employed your supporter must be 16 or over to support your application for Senedd elections. They must be 18 or over to support all other applications.

Your supporter must complete the relevant declaration section 8, 9 or 10.

If you are registered as a service voter (armed forces, Crown servant, British Council employee), you do not need support for your application.

If you are registered as an anonymous elector you do not need support for your application.

What happens after I've returned this form?

- Your proxy must go to your polling station to vote.
- You should tell your proxy how you want them to vote on your behalf, for example, which candidate, party, or outcome.
- The elections team at your council will tell your proxy when and where to vote on your behalf.

Privacy statement

We collect information under the legal basis of a task carried out in the public interest, as set out in the Representation of the People Act 1983 and related regulations. We will look after personal information securely and follow data protection legislation.

If you opted-out of the open register we will only use the information you give us for electoral purposes, including matching it against other sources of data to support the electoral register. We will not give personal information to anyone else, unless we have to by law. The law requires us to share your information with candidates, political parties and campaigners for democratic engagement purposes and credit reference agencies to check your identity when you apply for credit.

If you have <u>not</u> opted-out of the open register your name and address can be bought by anyone and used for lots of purposes, including direct marketing.

The Electoral Registration and Returning Officer is the Data Controller. You should refer to the Privacy Notices at <u>www.rushmoor.gov.uk/postandproxyprivacynotice</u> for further information relating to the processing of personal data.




