

Unemployment and benefits data sheet – January 2026

Summary – In December 2025, 3.0% of Rushmoor’s working age population were claiming out-of-work benefits principally for the reason of being unemployed.


Claimant Count analysis

“The Claimant Count is the number of people claiming benefit principally for the reason of being unemployed. This is measured by combining the number of people claiming Jobseeker’s Allowance (JSA) and National Insurance credits with the number of people receiving Universal Credit principally for the reason of being unemployed”

In December 2025 there were 2,080 Rushmoor residents claiming out-of-work benefits principally for the reason of being unemployed, a small increase from 2,040 in November 2025. Overall, 3.0% of Rushmoor’s working age population (16-64) were claiming benefits for the principally reason of being unemployed. This was a lower percentage than Great Britain (3.8 %) and the South East (3.1%) but a higher percentage than Hampshire (2.5%).

The following chart sets out the claimants as a percentage of the working age population, it shows a recent increase for Rushmoor, Hampshire and the South East

There are six wards that have a higher percentage of claimants than the Rushmoor average. The wards are Wellington ward (4.5%), Cherrywood ward (4.5%), Aldershot Park ward (4.5%), Empress ward (4.2%), North Town ward (4.0%) and Rowhill ward (3.6%).

The following table shows the number of people claiming out-of-work benefits principally for the reason of being unemployed in each ward in December 2025.



Claimant Count by female and males

The following chart shows the percentage of males and females claiming out-of-work benefits principally for the reason of being unemployed. Of the 2,080 residents claiming in December 2025, 1,140 were male (3.2% of the male working age population) and 940 were female (2.7% of the female working age population).

Claimant Count by age

The following table shows the age of residents claiming out-of-work benefits principally for the reason of being unemployed in Rushmoor.



In December 2025, 4.8% of 18-24 year olds were claiming. This is a lower percentage than Great Britain (5.6%), but a higher percentage than the South East (4.7%) and Hampshire (4.4%).

The following graph shows the percentage of residents claiming out-of-work benefits principally for the reason of being unemployed in Rushmoor as the percentage of the total population of each age group in Rushmoor.

Note: the time series data is currently showing different percentages for each group.

Percentage of residents claiming out-of-work benefits principally for the reason of being unemployed as a proportion of the resident population of the same age



Universal Credit

Universal Credit is a benefit for people on a low income or out of work, who are below pension age. It began being rolled out in Rushmoor in February 2016 and will replace most means-tested benefits and tax credits and will include payments for children and housing costs.

The following shows the number of people on Universal Credit in Rushmoor at the end of each financial quarter since the introduction of Universal Credit. Due to the pandemic there was a sharp rise in people on Universal Credit between March 2020 and June 2020.



Housing and Council Tax Benefit take up

Rushmoor Borough Council is responsible for Council Tax Support (CTS) and local Housing Allowance (this is now covered by Universal Credit for those of working age). The benefit caseload was 5,548 in December 2025.

The following table shows the number of claims has been declining over the past four years, due to people moving over to Universal Credit. However, whilst local Housing Allowance claims decrease, there has been a rise in those claiming Council Tax Support



Model based unemployment

Not everyone who is unemployed is entitled to claim out of work benefits, the Office for National Statistics (ONS) Annual Population Survey estimates the percentage of the working age population who are unemployed. It should be noted that this is model based and the ONS Annual Population Survey base the data on a small sample of people in the area.

This data estimates that there are 1,800 people unemployed in Rushmoor (3.2% of the economically active population).

The following table shows the unemployment rate in Rushmoor, the South East and Great Britain. Rushmoor has a lower rate than Great Britain and the South East.


