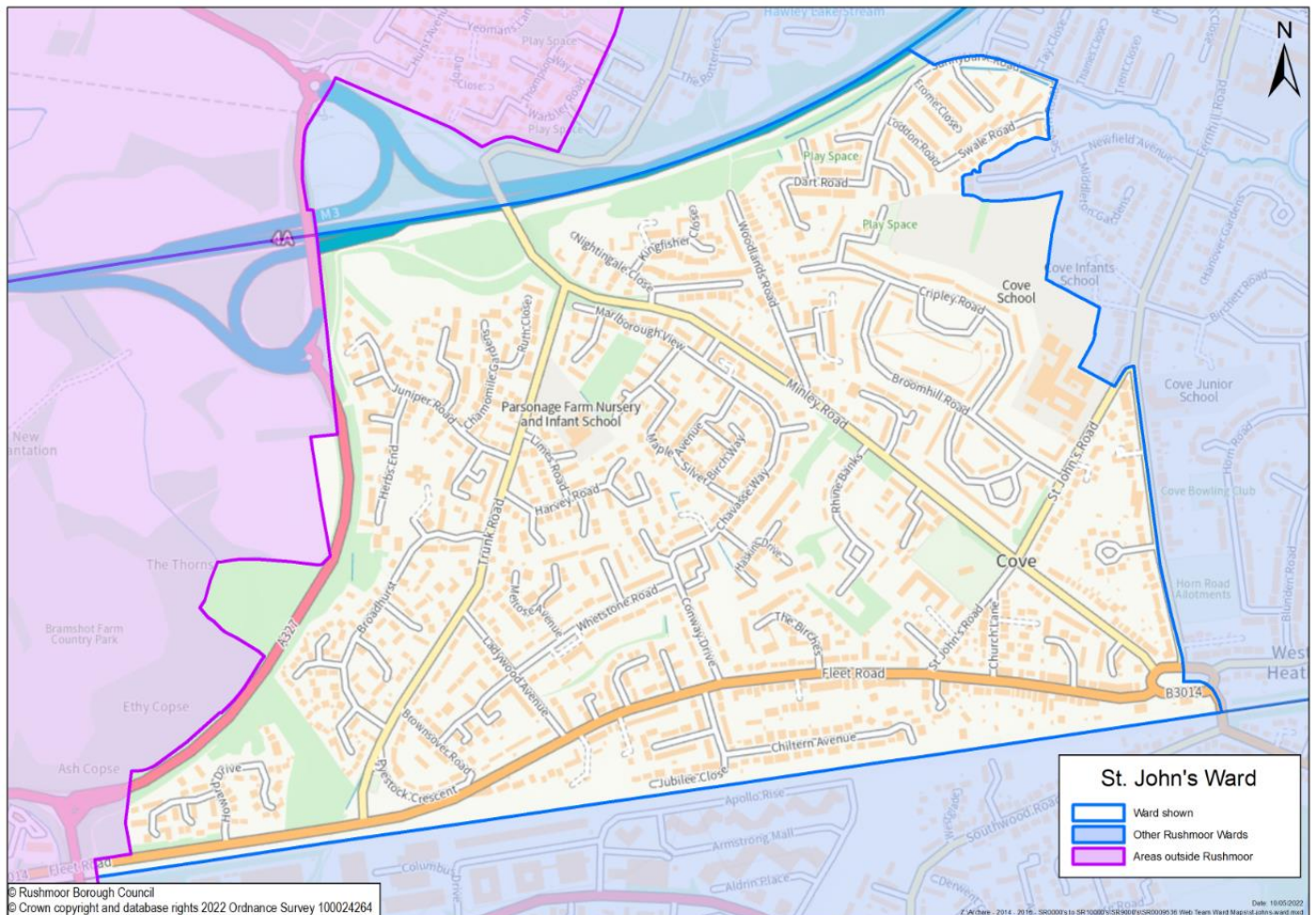

St John's covers the west of Farnborough, between the railway and the M3. Minley Road runs through the centre of the ward.



Resident survey results

The last Rushmoor Borough Council residents' survey where result can be produced at a ward level, was carried out in 2022. The survey was an online survey and 1,021 surveys were returned, in total 64 residents in St John's ward completed the survey. Although not all wards had a representative number of responses the results can give an indication to what respondents in a ward think.

Below is a summary of the results for St John's ward.

Top five factors that are important in making somewhere good to live and need improving by ward

Respondents from St John's ward have a higher satisfaction with Rushmoor as a place to live than respondents from Farnborough, and all respondents to the survey.

How strongly do you feel you belong to your local area? (very and fairly strongly)

Respondents from St John's ward feel less that they belong to their local area than those from Farnborough, and less than all those who responded to the survey.

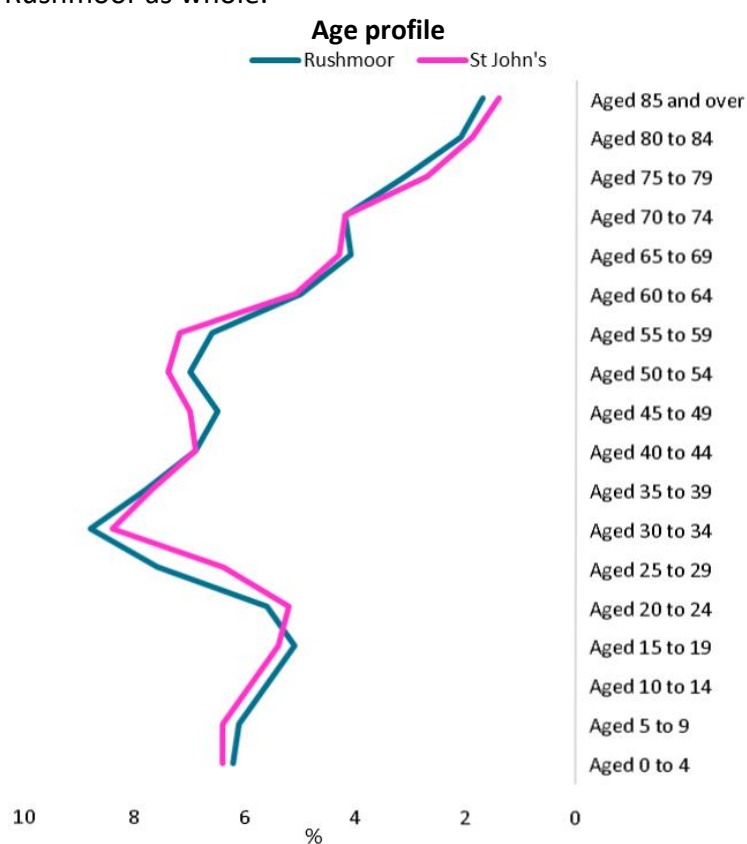
Ward population and makeup 2021

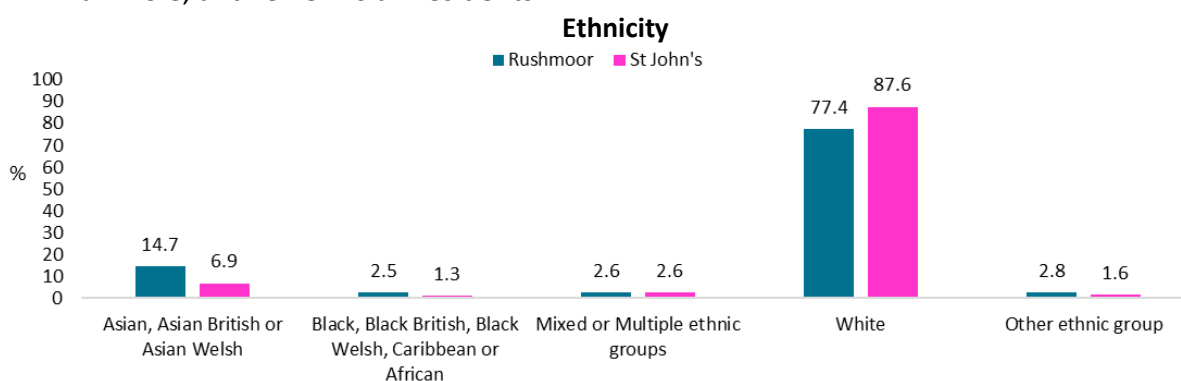
- Population:**

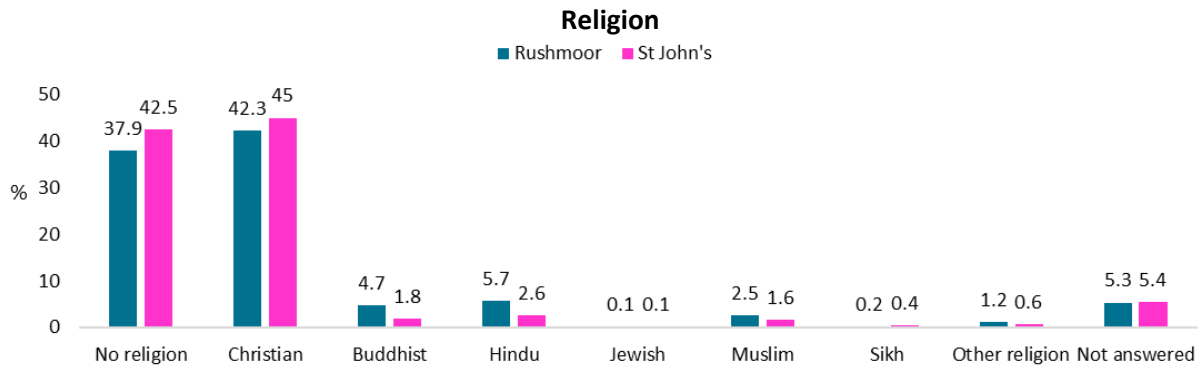
- Age:** There is not much difference between the age profile of St John's residents and the age profile of Rushmoor as whole.



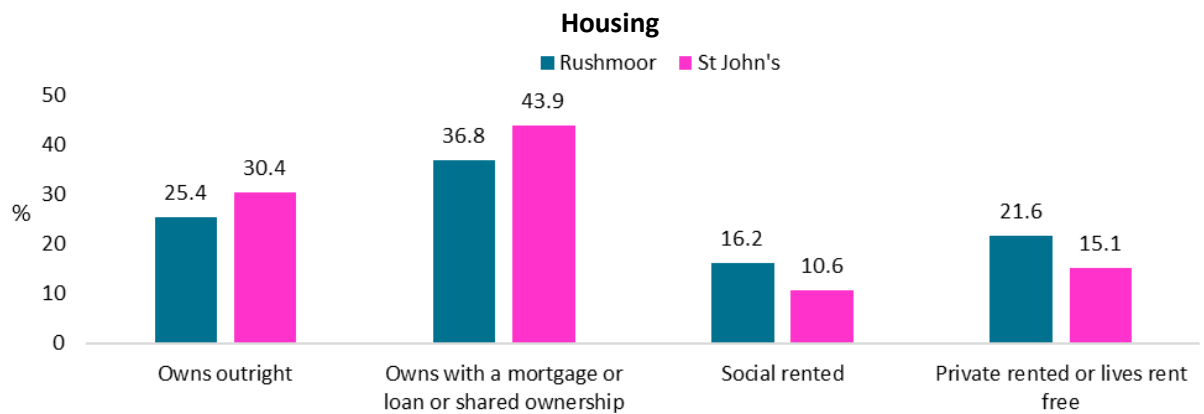
- Ethnicity:** St John's ward has a higher percentage of White residents, than Rushmoor as a whole, and fewer Asian residents.



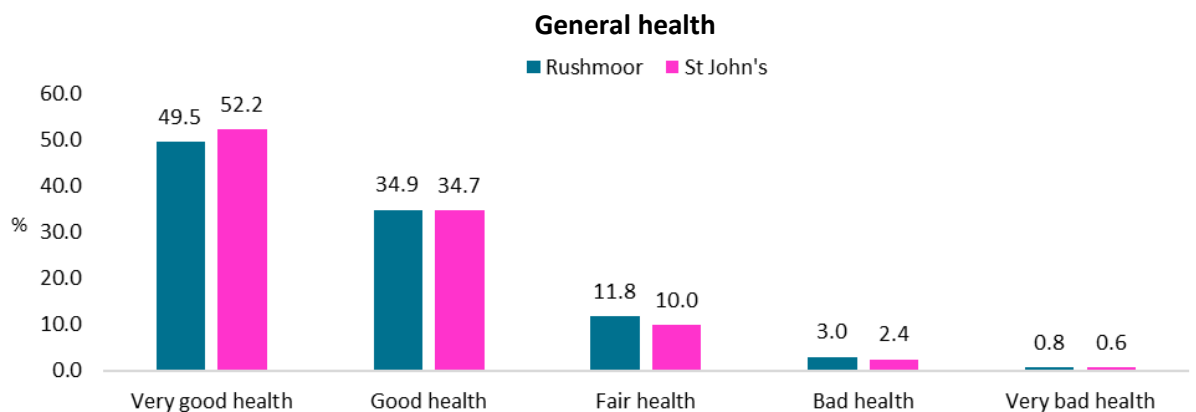
- **Religion:** There is a slightly higher percentage of residents with no religion, when compared to Rushmoor as a whole.



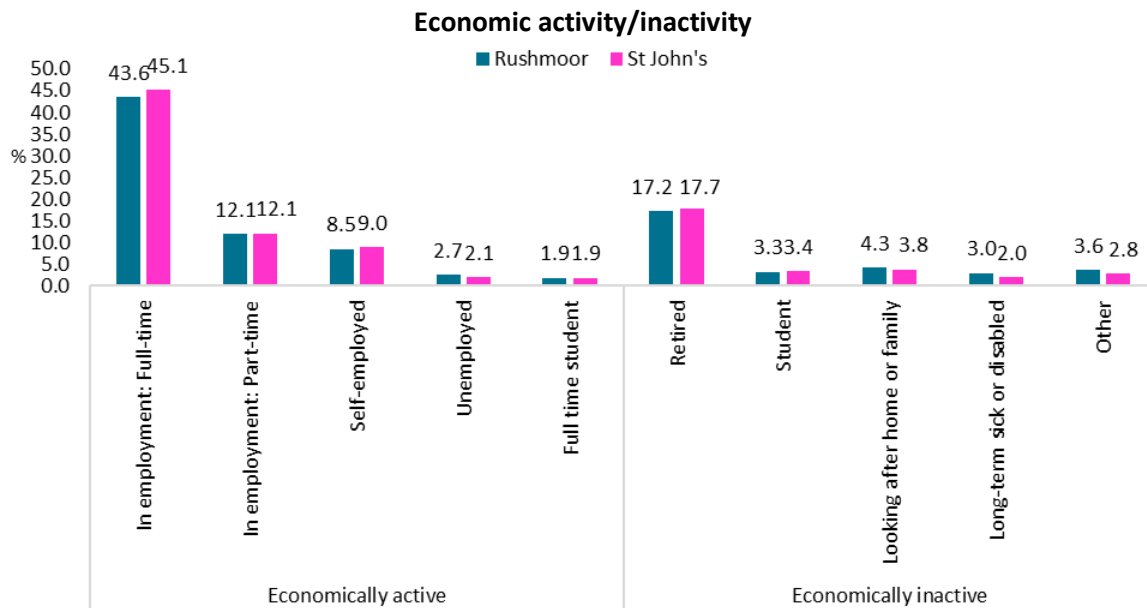
- **Housing:** A higher percentage of residents in St John's own their own homes, and a lower percentage rent from social landlords (housing associations) and rent their homes privately, when compared to Rushmoor as a whole.



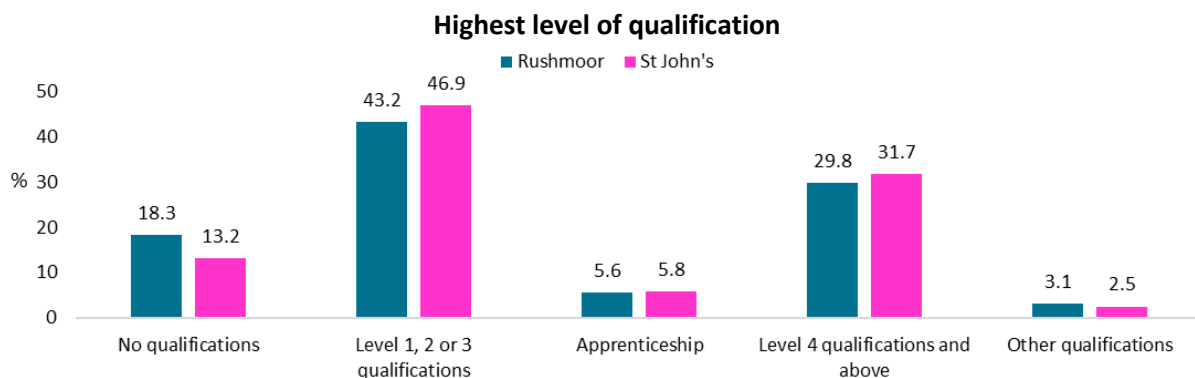
- **Health:** A slightly higher percentage of St John's residents reported very good health, when compared to Rushmoor as a whole.



- **Economic activity/inactivity:** St John's ward has a slightly higher percentage of residents in full time employment, when compared to Rushmoor as a whole.



- **Qualifications:** A slightly higher percentage of St John's residents have level 1, 2 and 3 as their highest qualification and a lower percentage have no qualifications, when compared to Rushmoor as a whole

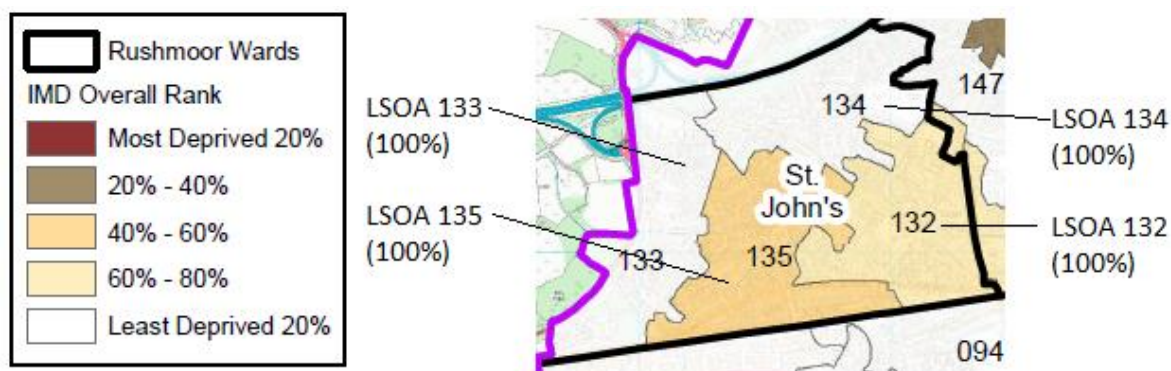


- Level 1 and entry level qualifications: 1 to 4 GCSEs grade A* to C , Any GCSEs at other grades, O levels or CSEs (any grades), 1 AS level, NVQ level 1, Foundation GNVQ, Basic or Essential Skills
- Level 2 qualifications: 5 or more GCSEs (A* to C or 9 to 4), O levels (passes), CSEs (grade 1), School Certification, 1 A level, 2 to 3 AS levels, VCEs, Intermediate or Higher Diploma, Welsh Baccalaureate Intermediate Diploma, NVQ level 2, Intermediate GNVQ, City and Guilds Craft, BTEC First or General Diploma, RSA Diploma
- Apprenticeship
- Level 3 qualifications: 2 or more A levels or VCEs, 4 or more AS levels, Higher School Certificate, Progression or Advanced Diploma, Welsh Baccalaureate Advance Diploma, NVQ level 3; Advanced GNVQ, City and Guilds Advanced Craft, ONC, OND, BTEC National, RSA Advanced Diploma
- Level 4 qualifications and above: degree (BA, BSc), higher degree (MA, PhD, PGCE), NVQ level 4 to 5, HNC, HND, RSA Higher Diploma, BTEC Higher level, professional qualifications (for example, teaching, nursing, accountancy)
- Other: vocational or work-related qualifications, other qualifications achieved in England or Wales, qualifications achieved outside England or Wales (equivalent not stated or unknown)

Deprivation breakdown

The Government's Index of Multiple Deprivation (IMD) 2019 provides a relative deprivation score for each small area in England, it covers a range of economic, social and housing issues. The overall score is calculated using data from seven domains. Most of indicator data has come from 2015 and 2016 and some of the data is from the 2011 Census. The Indices of Deprivation cover geographical areas that are called Lower-layer Super Output Area level (LSOA), of which there are 32,844 in the country. There are a total of 58 LSOAs in Rushmoor.

Unfortunately, LSOAs and the council's wards do not exactly line up. In St John's ward there are all or part of four LSOAs. The following map shows the number of the LSOAs in St John's ward and the approximate percentage of the LSOA in the ward. Each LSOA is ranked in order against all other LSOA in the country, where 1 is the most deprived and 32,844 is the least deprived.
