RECREATION CENTRE BYELAWS

Byelaws for regulating the use of Farnborough Recreation Centre, Aldershot Lido and Aldershot Indoor Pool and securing the good and orderly conduct of persons therein made under S.10 of the Hampshire Act 1983.

INTERPRETATION

1. In these byelaws:

‘the Council’ means Rushmoor Borough Council;

‘the Centre’ means all the buildings and other facilities (excluding car parks) at Farnborough Recreation Centre, Farnborough, Hampshire and at Aldershot Lido and Aldershot Indoor Pool, Aldershot, Hampshire;

‘equipment’ means all fixed apparatus within the Centre together with all apparatus provided by the Council or its contractors to enable persons to utilise the facilities contained within the Centre;

‘Authorised Person’ means all staff employed in a management position, whether employed directly by the Council or by its contractor.

ENTRY INTO THE CENTRE

2. No person shall:

- (a) use the Centre without payment for the use of facilities as appropriate;
- (b) without the consent of an Authorised Person, cause or permit any animal to enter the Centre other than guide dogs for the blind or dogs assisting deaf people;
- (c) enter the Centre whilst knowingly suffering from any infectious or contagious medical condition.

USE OF THE CENTRE

3. No person shall:

- (a) intentionally or recklessly interfere with the privacy, safety or comfort of any person in the Centre;
- (b) intentionally or recklessly damage, deface or soil any part of the Centre or any equipment provided therein;
- (c) without reasonable excuse prevent or impede any employee of the Council, or the Council’s contractor, from executing his duties;

- (d) smoke in the Centre except in designated areas;
 - (e) remain in the Centre or any part or parts thereof after having been informed that permission for him to remain in the Centre has been revoked by a proper officer of the Council;
 - (f) without lawful excuse destroy or damage any property belonging to another, intending to destroy any such property, or being reckless as to whether any such property would be destroyed or damaged;
 - (g) use any soap or similar substance in any swimming pool within the Centre or otherwise act in any manner likely to affect prejudicially the conditions of the water therein;
 - (h) deposit any rubbish or litter in the Centre otherwise than in a receptacle provided for that purpose;
 - (i) without reasonable excuse at any time obstruct or cause to be obstructed any doorway, entrance, corridor or exit situated at the Centre.
4. No person, other than a person duly authorised by an Authorised Person, shall bring into the Centre:
- (a) any bottle or container made of glass or other breakable material unless adequately protected from risk of breakage;
 - (b) any article or thing which would be reasonably likely to cause injury to any person or damage to the Centre or the equipment;
 - (c) any alcoholic drink of any kind.
5. Any person contravening any of these byelaws may be excluded or removed from the premises by any proper officer of the Council.

PENALTY

6. Any person who offends against any of the foregoing byelaws shall be liable on summary conviction to a fine not exceeding Level 1 on the standard scale.

REVOCATION

7. The byelaws relating to the regulation of the use of Farnborough Recreation Centre, Aldershot Lido and Aldershot Indoor Pool, which were made by Rushmoor Borough Council on the second day of May 1984 and signed by authority of the Secretary of State for the Environment on the 22 June 1984, are hereby revoked.
